This letter is to confirm your payment plan agreement with the Indiana Department of Revenue (DOR). All liabilities included in this payment plan agreement between [REDACTED] and DOR are listed on the back of this letter.

As part of this agreement, the balance of your tax debt is due in 24 monthly installments of \$50.00. The first payment is due on or before 02/15/2020. The last installment due will include a balloon payment of \$76,618.63. At the end of the 24 month period, DOR will review your agreement.

Your first payment coupon is attached to this letter and must be included with your payment to ensure that your account is properly credited. DOR will send you a new coupon each month.

Select Payment Plans, Liabilities and Cases. You must enter your Taxpayer Id number (TID) and Case Number (found at the top of this letter).

The terms of your payment plan agreement state that all tax returns must be filed and paid on a timely basis. Failure to file and make the payments timely will result in cancellation of your agreement and the full balance of the liabilities will be due.
