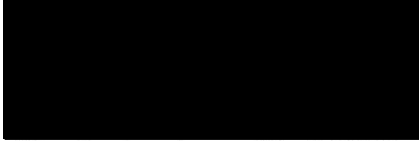




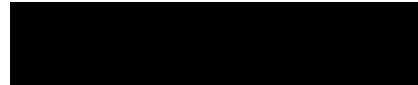

Re: Debt Owed To The State of Ohio

Dear Sir or Madam,

As you know the State of Ohio has the right to file post judgment collection proceedings against you and your assets because of the delinquent tax accounts noted above. This letter will confirm the agreement not to do so at this time, provided you do the following:

1. Make the payments as described on the next page.
2. You agree that the State of Ohio may commence an initial action to collect these taxes at any time in the future in the event you breach this payment agreement or taxes remain due at the conclusion of the agreement.

Failure to agree may result in the filing of post judgment collection proceedings against you or your assets. You must return a signed copy of this letter to prevent these proceedings. This agreement prevents civil proceedings against you. It does not affect any jurisdiction's right to take criminal action against you for the nonpayment of tax, nor does it prevent the filings of liens or income tax or lottery award offsets.

Please see attached page for details of your payment arrangement. Mail a check or money order payable to Ohio Treasurer of State as shown on the attachment. Payments must be made by the due date; there is no grace period. Please notate the account number on each payment to ensure proper posting.



1. \*Personal Checks: May take up to 14 days to clear both our bank and your bank:
2. If you send a payment for less than full amount:
  - A. If the check, money order or transfer order contains a notation such as "paid in full" or other words of restriction, the payment may be refused, cashed and refunded to you, or destroyed.
  - B. Other than 2A above, if your payment for less than the full amount is cashed and not returned or refunded to you, it may be applied but you will still owe the remaining balance.

  - B. A disputed payment does not stop collection activity. Interest and collection fees continue to accrue during the pendency of any dispute.
  - C. Collection efforts including but not limited to bank attachments, wage garnishments, debtor examinations may continue during the pendency of any dispute.
