



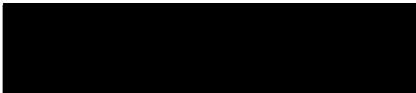

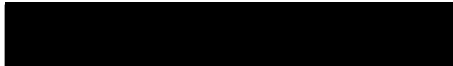

The Alabama Department of Revenue agrees to withhold action to collect your tax liability as long as monthly payments of \$200.00 are received in this office every 30 days beginning June 28, 2019. Additional interest, as provided by law under §40-1-44, Code of Alabama 1975, will accrue daily on the total unpaid balance at the same rate as established under the authority of 26 U.S.C. §6621.

Please submit your initial payment of \$200.00 within 30 days from the date of this letter. Any default of this plan, **or failure to file and pay any future taxes to the Alabama Department of Revenue**, will result in immediate collection action without additional notice. If you fail to respond, the Department will seize wages, bank accounts, real and/or personal property or rights to property belonging to you in the amount necessary to satisfy your tax liability, as authorized under §40-2-11(16), Code of Alabama 1975.

To ensure prompt credit of your payment, please create a new account or sign in to My Alabama Taxes (MAT) for all payments. For MAT online assistance in creating/viewing an established account, please call 1-800-322-4106. View your account online and make payments at: **<https://myalabamataxes.alabama.gov>**

If you are unable to access a computer with internet capability for the MAT account, submit your payment with the attached vouchers provided. You should write your account number, social security number, or Letter ID number on your payments made payable to the **Alabama Department of Revenue**. Installment Payment Agreement

TERMS OF AGREEMENT:

The Alabama Department of Revenue and the above-named taxpayer(s) hereby agree that said taxpayer(s) is/are legally indebted to the Alabama Department of Revenue in the current amount of \$31,393.95, which represents tax, penalty, and interest through May 29, 2019 for the type of tax and period shown above; and

In consideration of this agreement the Alabama Department of Revenue suspends its rights to collect this liability immediately, and the taxpayer hereby agrees as follows:

Payments of \$200.00 must be received in the Collections Services Division on or before the 28th day of each month beginning June, 2019.

This agreement will terminate on June 28, 2020 and the remaining balance will be due in full including accrued interest.

It is agreed and understood that the following conditions are made a part of this agreement:

- (1) Additional interest as provided by law, Section 40-1-44, Code of Alabama 1975, will accrue on the total unpaid balance at the same rate established under the authority of 26 U.S.C. § 6621.
- (2) All subsequent tax returns for taxes administered by the Department that become due while this agreement is in effect must be filed and paid by the due date.
- (3) **Liens have been recorded in MOBILE County by the Department and will not be released until the final payment has been received. Upon full payment, liens will be released in the due course of business unless otherwise directed.**
- (4) Any refund that may be due from the Department may be credited to this liability.
- (5) Collection Information Statements will be completed prior to the granting of an Installment Payment Agreement. Once granted, an Installment Payment Agreement may be terminated if it is determined that inaccurate information has been supplied.
- (6) The taxpayer agrees to furnish updated financial statements at the request of the Department and further agrees to promptly notify the Department of any significant change in financial condition that would result in the termination, alteration, or modification of this agreement.
- (7) Payments are to be made by cashier's check or money order payable to the State of Alabama and mailed to: **Alabama Department of Revenue, Collection Services Division, P.O. Box 327820, Montgomery, AL 36132-7820**. In the event of default, the Department may collect the balance due by any method allowed by law.
- (8) This agreement may be terminated by the Department upon notice to the taxpayer if collection of the liability is believed to be in jeopardy.
- (9) Agreements extended to corporations for the payment of trust fund taxes require the personal guarantee of the responsible corporate officer(s).
- (10) The Department of Revenue has the option of applying installment payments in a manner deemed most appropriate to the State.

This instrument contains the entire agreement between the parties, and no statement, promise or inducement made by either party that is not contained in this written agreement shall be valid or binding.
