Automatic payment deduction notice

Make manual payments until automatic payments begin

It may take up to 60 days to set up the automatic payments. We will notify you when the automatic deductions will begin. Until that time, we will send you monthly bills that require manual payment.

Inform us of changes

If any information on the authorization form changes (payment date, bank information, etc.), you must notify us at least **ten** business days before a payment is scheduled.

If we are unable to automatically deduct your monthly payment, you may be subject to additional fees, penalties, and further collection action.
